The 2019 Legislative session is proving to be, yet again, a very busy one! Please see the summary bill report article in this newsletter provided by Cathy Barankin. The complete initial 2019 bill report is available on the CIHC website (<https://cihconline.com>). The Board members are tracking 40 bills from this year's session that may impact our profession.

Your CIHC representatives are continuing to participate in the Statewide Young Worker Safety Partnership. Thank you to Richard Hirsh for preparing an update for this newsletter. The

CIHC also continues collaboration with National AIHA on several issues including outdoor worker protection from poor air quality due to wildfire smoke, general government relations activities, Young Worker Safety Task Group, and Cannabis Industry Task Group.

The CIHC presented a written petition to the Cal/OSHA Standards Board in December (Petition 572) which requests consideration of much needed changes to the landmark Injury and Illness Prevention Program regulations to enhance the effectiveness of IIPP written programs for our State's workers. Please refer to <https://www.dir.ca.gov/oshsb/petition-572.html> for a copy of the petition. We anticipate a decision on granting or denying the petition at the May 16th Standards Board meeting. If you are interested in supporting Petition 572, please contact me and I will be happy to provide guidance on the process. Board members continue to attend Cal/OSHA advisory committee meetings and Standards Board meetings to stay apprised of their activities and to provide comments and technical input on behalf of our local sections and our profession. Of particular note, a very recent regulatory arena development – Cal/OSHA has been directed by the Standards Board to develop an emergency regulation on outdoor worker protection from poor air quality due to wildfire smoke.

Capitol Report

The 2019 Legislative Session, the first half of a new two-year session, is off to a roaring start. With dozens of new legislators sworn in in January, I have been spending time meeting these folks and explaining what an Industrial Hygienist does for a living. With hundreds of new bills introduced in January and February, Pamela Murcell, our CIHC President, and I spent many afternoons going over the new bill introductions to decide which bills should be reviewed by our CIHC board members. At our board meeting in March we reviewed bills, took positions on those that were of relevance, and assigned board members to follow their progress and to take action to support those positions. March marks the beginning of committee hearings to decide the fate of these proposals.

There are a number of bills that we will be following, including bills dealing with ambulance employee safety, blood lead levels and lead based paint, air quality, Valley Fever, emergency preparedness, professional engineers, global warming, use of pesticides on school sites, and dozens of other topics are in the mix. As you know, the 2018 election has given us a new Governor, Gavin Newsom; Lieutenant Governor, Eleni Kounalakis (who also serves as the President of the Senate); State Controller, Betty Yee; and State Superintendent of Public Instruction, former Assemblyman Tony Thurmond. Xavier Becerra won a second term as Attorney General, and Alex Padilla won his second term as Secretary of State. New administrations mean new priorities, a revised list of budget goals, and new issues for legislators to tackle.

As you have no doubt read, the Legislature is also spending a considerable amount of time responding to federal mandates that are opposed by our state lawmakers, and the financial repercussions those positions will have on our state budget. These concerns will no doubt be a major focus during the development of our next state budget, which must be passed by June 15th.

And last, but not least, May is Young Worker Safety Month. CIHC will again sponsor a legislative resolution along with the California Partnership for Young Worker

Health and Safety to give the issue of safety for minors in the workplace some attention and to promote our responsibility to keep them safe from injury.

CIHC/AIHA-SVS Summit

On March 13, 2019, the 3rd Annual Occupational Health and Industrial Hygiene Summit was held in Sacramento, CA. This summit was sponsored jointly by the California Industrial Hygiene Council (CIHC) and the Sacramento Valley Section of the American Industrial Hygiene Association (AIHA-SVS). The day was a mixture of topics that included several Occupational Health and Safety presentations and a look into the Legislative process.

The Occupational Health and Safety topics included discussions related to Cal/OSHA's proposed Indoor Heat Illness Standard (which is now late based on a legislative requirement), Health Effects Advisory Committee (HEAC) process and PELs under consideration, Ergonomics, and the growing issues (pun intended) of the Cannabis industry. All four of these presentations were engaging and, especially related to the heat illness issue, several attendees stated that it was the clearest presentation that they have heard to date regarding this proposed regulation. Joel Cohen provided the heat illness presentation, and he, along with Joel Berman (both Joel's are CIHC Board members) have provided comments to Cal/OSHA related to the proposed standard. The Keynote luncheon speaker was John Howard of NIOSH, who presented on Artificial Intelligence and Worker Safety.

The Legislative Update, by our Legislative Advocate, Catherine Barankin, included a limited review of the current bills introduced in Sacramento that may affect our ability to practice our profession (which is a large part of the overall CIHC activities). Additionally, Gideon Baum, Principal Consultant to the Senate Labor and Industrial Relations Committee also spoke about the legislative process and his role in that process.

In summary, it was an enjoyable day, including a short interruption by a group of people walking by the outside of the building, playing musical instruments, protesting on an unknown issue. The interruption was short but amusing.

California Partnership for Young Worker Health and Safety

The CA Partnership for Young Worker Health and Safety met on February 21st, 2019 at the CA Dept. of Education in Sacramento. Cathy Barankin represented CIHC at the meeting. Other attendees included representatives from the Labor Occupational Health Program (LOHP), California Dept. of Public Health (CDPH), the California Association of Work Experience Educators (CAWEE), California Dept. of Education (CDE), State Compensation Insurance Fund (SCIF), Equal Employment Opportunity Commission (EEOC), Dept. of Industrial Relations Commission on Health and Safety and Worker Compensation (DIR/CHSWC), Dept. of Industrial Relations Division of Labor Standards Enforcement (DIR/DLSE), EHS Inc., and Cal/OSHA.

Kelsie Scruggs of [LOHP](#) gave a presentation on the recently held Young Worker Leadership Academy 2019. YWLA 2019 Teams included: Youth United for Community Action (East Palo Alto, CA), South East LA Youth Source Center (Los Angeles, CA), Orosi High School (Orosi, CA), JR Wooden School (Reseda, CA), Norte Vista High Dreamers (Riverside, CA), and Woodside High School (Woodside, CA). The YWLA is funded by DIR CHSWC, with additional 2019 sponsorship from the California School Employees Association (CSEA), the California Teachers Association (CTA), Copper Point Insurance Companies, the International Union of Operating Engineers (IUOE) Local 12, Laborers International Union of North America (LIUNA), Pacific Compensation Insurance Company, the State Building and Construction Trades Council of California (SBCTC), and SCIF. Emely Heras of LOHP discussed the [young-workers.org](#) website analytics. The Work Permit page has the most page views. Most people find the website through search engines. Participants were interested to know whether there is data available to understand which materials are being downloaded. CAWEE plans to link their website to the work permit page. Regarding the work permit exam, a downloadable certificate is provided for those who pass the exam. One prospect would be for the Work Permit Quiz to be a required activity as part of YWLA team projects. While it is useful to provide a level of independence for YWLA participants when it comes to their planning time to create a community

project after YWLA, the work permit quiz data and work permit quiz could be highlighted as a resource.

There was a willingness to explore the idea of having YWLA participants take the work permit quiz before and after they complete their community projects. It has been reported that some participants are working in roofing activities or may be in violation of other child labor laws. Having the Work Permit Quiz available in various languages (e.g. English, Spanish, Chinese, Russian, Tagalog) would be an improvement to facilitate youth, employers and parents to taking the exam. For CA K-12 schools, if a language group represents at least 13% of the student population, then materials need to be provided in that language. The Work Permit Quiz was recently translated into Spanish and a Spanish version of the "Are You a Working Teen?" factsheet is available. Partnership members could assist in getting these resources out to groups that need the Spanish version. If Partnership funding becomes available other translations of the factsheets are possible. It was suggested that the quiz should show users which questions they got wrong, in order to improve their performance when retaking the exam. While there is no specific version of the work permit quiz for parents or employers, they could be developed and advertised. One idea would be to utilize YWLA youth to provide feedback on the Work Permit Quiz.

Partnership member updates: CAWEE will be holding a conference on October 2-4, 2019. Career Technical Education (CTE) is the theme this year – promoting Work Experience Education (work plus class for credit) as a capstone class. The Request for Presentations is currently open. CAWEE has scheduled 6 dates for Work Permit Certification Workshops, available in Los Angeles, San Diego, and Fresno – more information is available on the website <https://www.cawee.org/>

EHS Inc. is currently partnering with University of California at San Diego Learning Institute for young adults that are interested in pursuing a career in construction health and safety. EEOC representative Linda Li presented at the fall Partnership meeting on EEOC's sexual harassment prevention initiatives, but due to the government shutdown, she did not have a chance to follow-up on any next steps identified. One idea was to connect with CAWEE around presenting at their October conference. SCIF is launching a New Online Safety Resource designed to help California employers protect their workers and build cultures of safety <http://www.safeatworkca.com/>. The new site fea-

tures a variety of safety-related resources, including:

- Workplace safety fundamentals customized for a variety of industries
- Safety meeting topics and plans
- Updates on legislative and regulatory changes that impact California businesses, such as Cal/OSHA's new accident reporting requirements and the new hotel housekeeping musculoskeletal injury prevention requirements
- 2019 Employer Education Series safety seminar schedule


CIHC remains actively involved with the AIHA Teen Safety initiative with Diane Bush of LOHP and Richard Hirsh, CIHC Board member, participating in the national monthly calls. Diane shared a draft of the AIHA Teen Safety "Health and Safety for Youth at Work" flyer for employers. Local AIHA chapters are being encouraged to get their members out to school and community settings to conduct sessions concerning H&S for young workers. Diane has connected with the Northern California Section lead on this (Steve Hemperly) and has offered her services to other AIHA CA local section Teen Safety leads to assist with their efforts. One key challenge is how we as professionals can engage employers to support the effort to keep young workers safe?

Diane Bush gave an overview of two projects related to supporting safety and health education in career technical education. These include:

1. Training for teachers on the Youth @ Work curriculum (supported by Dept. of Education), providing 12-15 free workshops: "Keeping Your Students Safe on the Job for Linked Learning", for Career Technical Education, Career Pathway Academy, WorkAbility and other Work-Based Learning teachers. A workshop on how to teach 21st Century health and safety critical thinking skills using fun, participatory activities, with the [Youth @ Work: Talking Safety curriculum](#) is available from the National Institute for Occupational Safety and Health (NIOSH). Diane is sharing tools to help ensure that external field placements are meeting safety and health responsibilities to keep student learners safe. Diane also demonstrated the Safety Pyramid Game from the Youth@Work curriculum, which focuses on controlling hazards.

2. The Promoting Injury Illness Prevention Program (IIPP) critical thinking skills linked to OSHA 10 training. One gap identified in previous research is the lack of explicit training and practice in these programs to ensure that new workers have strong critical thinking and problem-solving health and safety skills. Diane is working on a small pilot project to develop teaching tools that can augment the OSHA 10-hour or other health and safety training, to help instructors address gaps in hazard recognition, hazard control, on the job problem solving and communication. LOHP is also developing a generic version of YOUR CONSTRUCTION SAFETY PROGRAM: SAFE STUDENTS, SAFE WORKERS: A Guide for Administrators & Instructors in Post-Secondary Career Technical Education (CTE).

It was mentioned that CTE Anchor standards, Work Experience Education standards, and other Work-based learning standards highlight the need to teach health and safety as part of these programs, but these need to be accompanied by details about how to do this along with a focus on emphasizing that these are critical thinking skills—not just passing a safety test. If we want employers to get involved, an effective message is that "Safety Pays". (Resource: World of Work, New World of Work <https://www.newworldofwork.org/>.)



Safe Jobs for Youth Month, 2018 First Place Poster created by Sofia Kim, Los Angeles, CA


May is [Safe Jobs for Youth Month](#) (SJFYM). Kelsie Scruggs of LOHP gave a brief overview of past activities. The winners of the SJFYM Poster Contest 2019 will be announced in May and posted on the website; posters will be mailed to 1000+ high schools, plus libraries, Boys & Girls Clubs, etc. High school age interns from the CORO Fellowship Program have created a video for EEOC. Teens Lead @ Work (TL@W) peer leaders are currently hired by LOHP and paid through the Berkeley Youth-

Works youth employment programs. TL@W youth could also work on a video if they develop the skills. For the SJFYM Social Media Campaign LOHP has asked Partners to complete a form indicating the ways in which they or their organization/agency can support SJFYM (i.e., city proclamation, press release). Cathy Barankin of CIHC volunteered to work on a 2019 Safe Jobs for Youth Month Resolution. The Partnership would like to secure a media presence and could use Partner support. A pre-made press release may be disseminated to Partners. LOHP may explore working with Oakland Youth Radio and KPFA radio stations and other outlets.

A discussion was also held on SJFYM activities and campaign ideas with a goal of completing this exercise by early April. CDE-funded teacher workshops could be targeted to participate themselves or through their students via contests (e.g., Work Permit Quiz participation rates; conducting hazard map activities and posting pictures to social media). A suggestion was raised to consider using a bit.ly link to track webpage use based on the outreach for a specific campaign- similar to the functionality of MailChimp. A PTA Newsletter article could be crafted. Additionally, an educational resource for employers could be developed in conjunction with the Chamber of Commerce, to include a message to the effect: "Be a safe place for youth to work" and "Are you ready?".

There are many good resources that could use more promotion, like the Sexual Harassment Kahoot Quiz and Work Permit Quiz. One suggestion was to create a webinar for employers of youth with the Oakland Chamber of Commerce

and Golden Gate Restaurant Association.
