TALC CLAIMS

Failure to Warn and Design Defect.

Johnson & Johnson baby powder started manufacture in 1967

First study linking talc powder and cancer in 1982

The company denies its product contained asbestos

Plaintiff uses J&J memos allegedly showing knowledge of asbestos in its talc

Talc Suits

Over 5,500 suits against Johnson & Johnson nationwide

Missouri verdicts re ovarian cancer: 4 of 5 for plaintiff

One Missouri verdict for \$72 million, overturned on appeal

Another Missouri verdict for \$110 million upheld by trial judge

Show-Me State home for talc litigation?

What about Bristol-Myers Squibb?

California Cases

Over 300 talc cases in California

Lloyd v. Johnson & Johnson, BC628228

\$417 million talc verdict overturned on JNOV by Los Angeles trial Judge Maren Nelson

Lengthy analysis of scientific articles in 70 page opinion

IARC's conclusion that talc is "possibly carcinogenic" is insufficient as a matter of law to require any warning
