Back in 1990, a group of industrial hygienists met in Sacramento to talk about the state of the profession, and to learn about the legislative process and how to influence it. They affixed buttons to their clothes with the phrase "What is an industrial hygienist?" and spent the day walking the Capitol corridors educating legislators and their staff about the profession. The results of these initial efforts ultimately led to Certified Industrial Hygienist (CIH) title protection, definition of industrial hygiene in the Business and Professions code, and additional regulatory and legislative recognition of the important role industrial hygienists play in the anticipation, recognition, evaluation, and control of hazards in the workplace and environment.

However, our work is never done. As new laws and regulations are proposed and as new legislators come and go, it is important for industrial hygienists to continue to be active in the process and to ensure our contributions continue to be recognized. The need to educate legislators and their staff about "What is an industrial hygienist?" is no less important today than it was almost three decades ago! I'll provide a summary of our work for 2018 in this year's CIHC update.

The CIHC Board represents you. The Board is regularly in need of technical advisors. The Board consults with technical advisors to gather information and details on specific issues that will assist the Board in commenting on proposed legislative bills and draft regulations. Technical advisors could also represent CIHC on Cal/OSHA Advisory Committees. *What area of expertise is your professional passion?* Contact your local CIHC Board member or me (530-622-7196) to let us know. Overview of CIHC

Purpose

- Seek recognition in statutes defining, recognizing, and protecting the profession of industrial hygiene
- Provide sound scientific and technological input to the legislative and regulatory process

Legislative Services

- CIHC contracts with Sacramento Advocacy to provide legislative support and advocacy for our profession
- Professional legislative support is essential especially during the current state economic climate where
 many health and safety programs are or have been considered for elimination or modification
- CIHC Directors, representing the five local California sections of the American Industrial Hygiene Association (AIHA), volunteer their time to support CIHC activities

Activities

- Review and monitor legislation (in 2018, the CIHC Board screened several hundred bills and actively monitored over 100 bills which may impact the industrial hygiene profession, and took a position on 65 bills)
- Sponsor legislation
- Review and comment on proposed regulations through participation in Advisory Committees
- Sponsor annual CIHC Conference/PDS
- Coordinate with AIHA National Government Affairs

Major Accomplishments

- Defined Industrial Hygienist in State Law (H&S Code 117672)
- Initiated and Sponsored the Industrial Hygienist Definition and Registration Act (B&P Code Sections 20700-20705)
- Established and maintained legislative presence in Sacramento
- Negotiated to reduce the number of days for lead training course for CIHs to three days
- Negotiated the exemption for Trauma Scene Waste Management Practitioner requirement
- Monitored rewrite of the Professional Engineers Act
- Sponsored laboratory accreditation legislation
- Sponsored successful legislation to allow a CIH or other qualified professional to provide lead poisoning prevention services
- Garnered strategic legislative amendments to the Toxic Mold Protection Act of 2001 assuring the participation of IH's in developing standards to identify, evaluate, and abate mold
- Provided comments on a wide range of proposed regulations: heat illness prevention, lead in construction and general industry, ergonomics (housekeeping in hotel and hospitality facilities), injury and illness prevention, permissible exposure limits

Annual CIHC Conference/PDS

- Provides a statewide forum to discuss issues of concern to the industrial hygiene profession
- Provides educational opportunities for industrial hygienists and allied professionals
- Strengthens ties and establishes alliances among the OEHS professionals



Respiratory Protection Regulations: <u>"There is Another" (Yoda, "The Empire</u> Strikes Back"

Exposure and Health Impacts of Smoke for Wildland Firefighters



Kathleen Navarro, PhD, MPH

Forest Planning Specialist Manti-La Sal National Forest US Forest Service

Kathleen Navarro works for the United States Forest Service (USFS) and is qualified as a wildland firefighter. She has evaluated wildfire smoke exposure (particulate matter, carbon monoxide, and polycyclic aromatic hydrocarbons) for the public and wildland firefighters through direct monitoring at wildfires. Currently, she is using field collected smoke exposure measurements to estimate risk of lung cancer and cardiovascular mortality for wildland firefighters. Kathleen completed her PhD in the Environmental Health Sciences at the UC Berkeley School of Public Health, where she also completed her MPH degree in 2011. Her dissertation combined traditional methods of exposure assessment with new approaches to evaluate exposures in ambient community and occupational settings to air contaminants commonly emitted from wildfires. She has a Bachelor of Science degree in Environmental Toxicology from UC Davis.

A State Agency Perspective on Post-Fire Debris Cleanup



Todd Thalhamer, PE

Sr. Waste Management Engineer CalRecycle

Todd Thalhamer is a registered civil engineer and a senior waste management engineer for CalRecycle. He recently retired from El Dorado Hills Fire Department as a Lieutenant after 19 years of service. He received his Bachelor of Science degree in Environmental Resource Engineering from Humboldt State University in 1992. After four seasons as a wildland firefighter for CalFire, he began working for the California Integrated Waste Management Board (now CalRecycle) in 1992 as a waste management engineer. During his 25 years in the waste industry, he has managed many environmental responses, large scale debris operations, and hazardous waste removal projects. Todd has been responsible for a number of large-scale suppression responses at major waste facilities throughout the United States, Canada, and overseas. He is currently working for the World Bank on a large-scale landfill fire resulting from the two hurricanes that impacted the island of Saint Maarten. One of Todd's duties during natural disasters is acting as CalRecycle's Operations Section Chief for debris recovery projects where he has managed the hazardous and solid wastes from residential and commercial structures destroyed by wildfires.

Todd designed and implemented California's first Structural Wildfire Ash and Debris Removal Program for Private Property Debris Removal (PPDR) for the California Governor's Office of Emergency Services (Cal OES) in 2007. Last year this plan was used by the US Army Corps of Engineers for Federal Emergency Management Agency (FEMA) funded PPDR disaster work at over 8,000 residential and commercial properties. He currently is performing engineering duties for state and federally funded disaster operations including developing scopes of work for emergency/temporary bridge crossings, sampling strategies, soil backfill projects, hazmat responses, commercial waste removal, and site characterizations.

Todd has performed duties as the Incident Commander/Operations Chief/Disaster Matter Expert for multiple FEMA and Cal OES funded debris operations in El Dorado, Butte, Calaveras, Lake (4x), Mono, Nevada, San Bruno, Ventura, and Yuba Counties. Coordinated the removal of over 3,000 residential structures and other debris; directly supervised a debris incident command team that consisted of multiple state and county agencies, contractors, waste haulers, environmental consultants, and health and safety consultants and worked with both FEMA and local government representatives during the responses.

Todd has also designed and implemented debris removals for snow and during extreme weather conditions, and acts a liaison to local government, schools, and community members at public meetings for multiple PPDR projects. To add to his debris experience, he has recently completed a number of abandoned vessels removal projects in the waters of SF Bay Area, Delta, and Lake County.




